**Bond Issues:**

**The bonds described below that are approved may be combined into a single issue or may be issued in series from time to time. If the bonds for one or more of the purposes are approved, there will be levied a one half of one percent (.50%) sales and use tax for the sole purpose of retiring bonds. The net collections of the tax remaining after the State of Arkansas deducts its administrative charges and required rebates will be used solely to retire the bonds and obligations of the City with respect thereto. The rate of taxation will be one half of one percent (.50%) even if bonds for more than one purpose are approved.**

**BALLOT ISSUE**

FOR or AGAINST an issue of bonds of the City of Maumelle, Arkansas in the maximum principal amount of \$15,595,000 which, together with other available moneys, will finance new, or improvements to existing, streets, roads and related structures constituting a new interchange at the intersection of Counts Massie Road and Interstate 40, including particularly, without limitation, overpasses and bridges and any necessary easement and right of way acquisition and related intersection improvements, drainage, utility adjustments, lighting and traffic control devices and improvements therefor, and, in order to pay the bonds, the levy and pledge of a one half of one percent (0.50%) local sales and use tax within the City.

**BALLOT ISSUE**

**FOR or AGAINST the levy of a one-half of one percent (0.50%) Sales and Use Tax, the net collections of which remaining after the State of Arkansas deducts its administrative charges and required rebates, shall be dedicated to and used for one or more of the following purposes:** (a) to provide funds for the operation and maintenance of the City's public safety facilities and activities including, but not limited to, the City's Police and Fire departments, street and trail repairs, street lighting, and other related public safety facilities and operations; (b) to pay and secure the repayment of bonds approved by the voters and issued by the City from time to time to finance and refinance new, or improvements to existing, streets, roads and related structures constituting a new interchange at the intersection of Counts Massie Road and Interstate 40, including particularly, without limitation, overpasses and bridges and any necessary easement and right of way acquisition and related intersection improvements, drainage, utility adjustments, lighting and traffic control devices and improvements therefor (the "Street Improvement Bonds"); and (c) to pay and secure the repayment of bonds approved by the voters and issued by the City from time to time to finance and refinance extensions, betterments and improvements to the sewer system located in the City in the Morgan Interchange area (the "Sewer Improvement Bonds").
