Commissioner Stahr moved to approve the unopposed candidates for the November 3, 2020 General Election; seconded by Commissioner Price. Motion passed by voice vote.

Approve Temporary Polling Location Change Orders for the December 1, 2020 General Election Runoff

Two of the polling locations for the December 1, 2020 General Election Runoff will not be available for the runoff election. Precinct 24, St. Anne's Parish Hall has decided they no longer want to be a polling location, voters for this precinct will be moved to Precinct 25, North View Missionary Baptist Church. Precinct 99/100, St. Luke United Methodist Church building has been sold, voters for this precinct will be moved to Precinct 98, Second Baptist Church on John Barrow Road.

Commissioner Stahr moved to approve the emergency temporary polling location change order for Precinct 100 to Second Baptist Church replacing St. Luke United Methodist Church for the December 1, 2020 General Election Runoff; seconded by Commissioner Price. Motion passed by voice vote.

Commissioner Stahr moved to approve the emergency temporary polling location change order for Precinct 99 to Second Baptist Church replacing St. Luke United Methodist Church for the December 1, 2020 General Election Runoff; seconded by Commissioner Price. Motion passed by voice vote.

Commissioner Stahr moved to approve the emergency temporary polling location change order for Precinct 24, to North View Missionary Baptist Church replacing St. Anne's Parish Hall for the December 1, 2020 General Election Runoff; seconded by Commissioner Price. Motion passed by voice vote.

Approve Amended Polling Location Order for the December 1, 2020 General Election Runoff

Commissioner Stahr moved to approve the polling location order as amended for the annual school election for the December 1, 2020 General Election Runoff; seconded by Commissioner Price. Motion passed by voice vote.

Approve Amended Notice of Election for the December 1, 2020 General Election Runoff

Commissioner Stahr moved to approve the amended notice of election for the December 1, 2020 General Election Runoff with the edit of changing Barrow Road to John Barrow Road; seconded by Commissioner Price. Motion passed by voice vote.

Certification of Logic and Accuracy Testing for the December 1, 2020 General Election Runoff

Commissioner Stahr requested Mrs. Dickens to explain the meaning of over votes and under votes. Mrs. Dickens explained that over votes are when a person votes for more than one candidate on a ballot and an under vote is when a voter chooses not to vote a candidate in a race. The DS200 will not allow a voter to mark more than one candidate, however this is possible on a paper ballot. Commissioner Price moved to certify the logic and accuracy testing results for the December 1, 2020 General Election Runoff; seconded by Commissioner Stahr. Motion passed by voice vote.

Update from Adam Fogleman, County Attorney

Mr. Fogleman provided an update regarding the lawsuit filed by Jim Sorvillo regarding the outcome of the House District 32 election results for the November 3, 2020 General Election. He provided a summary of the response that he was preparing regarding this matter.
