The meeting was called to order by Chairperson Ozell Snider. A quorum was determined; all members present.

## Approval of Meeting Minutes, November 9, 2012

It was moved by Commissioner Inman; seconded by Chairperson Snider. All in favor; motion passed unanimously.

### November 6, 2012 General/NPJ General Runoff Election

#### Provisional Ballot Certification

Total Provisional Ballots Authorized are as follows:

A total of 638 provisional ballots reviewed. 195 - Yes 443 - No

It was moved by Commissioner Inman and seconded by Chairman Snider. All in favor; motion passed unanimously.

#### Certification of Election Results

It was moved by Commissioner Inman to certify the election results; seconded by Chairman Snider. All in favor; motion passed unanimously.

Because of issues with ballots on Election Day, Commissioner Wyrick requested that the vendor, Bruce Bender of Advanced Print Solutions, appear before the Board to discuss issues with ballot printing for the General Election and that officials in the County Purchasing Department appear to discuss the bid process for county vendors.

Chairman Snider agreed and requested that the ballot vendor provide assurances to the commission to prevent problems in the future.

Commissioner Inman noted that the printer was made aware of problems with the ballots and he was at one location, Pulaski Academy to correct the errors.

It was moved by Commissioner Wyrick and seconded by Commissioner Inman to invote Bruce Bender and the County Comptrollers office to discuss printing issues and printing contract procedures. All in favor; motion passed unanimously.
