May 12, 2015 PCSSD Special Millage Election

Approval of Provisional Ballots

Commissioner Boyle moved to accept final approval of provisional ballots. Commissioner Gorman seconded. Motion passed by voice vote.

Approval of Official Election Results May 12, 2015 PCSSD Special Millage Election Four (4) Absentee Ballots, two Provisional Ballots added to final results. Results were as follows:

July 14, 2015 Little Rock Special Election (CALS)

EV1 site will be the only early voting site to be open. Due to CALS, all other sites are libraries and would be in conflict with this election.

Temporary Location Changes

Precinct 63 - Martindale Baptist to be combined with Precinct - 60 Highland Valley UMC

Precinct 123 - Southwest Community Church to be combined with Precinct 124 - Metropolitan Career Center

Commissioner Boyle moved to accept temporary location changes. Seconded by Commissioner Gorman. Motion passed by voice vote.

At the request of the commissioners, Steve Satterfield will seek approval to notify voters of temporary changes for this election.

Permanent Location Change

Precinct 82 - formerly Mabelvale UMC has been changed to Lifeline Baptist Church

There will be a total of 57 locations for 70 precincts.

Approval of Ballot Styles

Seventy (70) ballots styles approved. City Attorney Tom Carpenter approved ballot language via memo. Commissioner Boyle moved to accept ballot styles. Seconded by Commissioner Gorman. Motion passed by voice vote.

Certification of Notice of Election

Commissioner Boyle moved to certify Notice of Election. Commissioner Gorman seconded. Motion passed by voice vote.
