119 ballot styles. Motion to approval ballot styles made by Commissioner Boyle; seconded by Gorman. Motion passed by voice vote.

Approval of Notice of Elections (NOE)

Approval of NOE for the North Little Rock District, Jacksonville/North Pulaski School District and Little Rock School District. Mr. Poe noted that Pulaski County Special School District conducted its millage election in May 2015. Motion to approve made by Commissioner Boyle; seconded by Commissioner Gorman. Motion passed by voice vote.

Chairman Hays asked if Pulaski County Special School District has submitted payment for the May 12, 2015 Election. Payment was deposited into the County Treasurer's office on June 17, 2015. The cost was \$38,779.36.

Approval of Adjusted Precinct Orders

David Berman explained that the process to implement the approved precinct orders can be done within a week. He stated that all of the information on street segments has been completed. All that needs to be done is to implement that information and get voters placed where changes need to be made. The goal is to notify voters of precinct changes prior to the Annual School Board Election in September.

Motion to approve precinct boundaries Commissioner Boyle; seconded by Commissioner Gorman. Motion passed by voice vote.

OTHER BUSINESS

The AR County Election Commissioners Association (ACECA) will meet on Tuesday, August 25, 2015 from 10:00 a.m. to 3:30 p.m.

Mr. Poe and Assistant County Attorney Adam Fogleman met with Tim Humphries, General Council, SBEC, and Leslie Bellamy, AR Secretary of State's Office to discuss the proposed changes to provisional ballot procedures recently. Mr. Poe has drafted a memo and will be presenting a proposal requesting change of verbiage to procedures for the review process of provisional ballots. Chairman Hays suggested that Mr. Poe talk to other counties to find out how the provisional ballot review process is conducted in other counties. Mr. Poe will redraft his memo and resubmit to commissioners for final review before presenting it to the SBEC.
