Lonoke County Voters

The poll book provided by Lonoke County for the Jacksonville /NP Pulaski School District Special Election contained voters who were not eligible to vote in this election. The book should have contained precinct splits 24.1, 24.2 and 24.4. The book provided contained all voters in the 24.7 precinct split. The election officials were instructed to call the county clerk's office to determine which voters would have been eligible to vote in the election.

Mr. Poe stated that a couple of polling locations came close or did run out of ballots. Those locations were instructed to use the iVotronic voting device if ballots were depleted. One of those polling placed did run out of ballots and were told to use the remaining ballot style for that location because it was a single issue ballot.

Mr. Poe noted that when the ballot order was received it was discovered in the Excel spreadsheet that the Democratic Ballot order for the Preferential Primary on March 1, 2016 was offset by one (1) ballot style and quantity. This affect twelve (12) ballot styles. When corrected an additional quantity of 3,100 ballots in the group of twelve (12) ballots styles was ordered.

There will be a makeup training session for election officials who have not attended training for the Primary Election on March 1, 2016. There are 63 election officials remaining to be trained. The training session will take place on Saturday, February 20, 2016 from 10:00 a.m. to 12:00 p.m.
