Precinct 53 - Bethany Baptist Church will no longer serve as a polling location. It will be combined with Precinct 54 - Calvary Baptist Church.

Saline County will be receiving new voting equipment. Mr. Poe has spoken with the county clerk who has proposed to transfer any current voting equipment over to Pulaski County after Saline County is up and running with the new equipment. At the commission's request, Mr. Poe will research what the process will be for making this transfer between Saline and Pulaski County and refer back to the commission.

Mr. Poe noted that the meeting, previously scheduled for June 12, 2017, with the City of Jacksonville has been postponed to Wednesday, June 20, 2017.

The board discussed the interview process to take place for the office administrative assistant position being vacated next month. They agreed to have Mr. Poe make the final candidate selections down to two or three. The board will meet with each candidate during the interview process. Afterwards, the board will make recommendations accordingly to assist Mr. Poe in the final selection process.
