#### Annual School Election

Provisional ballot hearing for the September 19, 2017 election, there were four provisional ballots accepted. Commissioner Boyle moved to certify the provisional ballots; Commissioner Harris-Ritter seconded the motion. Motion passed by voice vote.

## **Certify Official Election Results**

Copies of the certification results will be provided to the Circuit Clerk's office, School Districts or Candidates, the Board of Education and one copy will be placed in the file. There will also be a memo submitted regarding North Little Rock Board of Directors School Zone 5 position. No one filed for candidacy during the filing period. Under Arkansas Constitution 19 § 5, the incumbent shall continue in office after the expiration of their official terms, until their successors are elected and qualified. Commissioner Harris-Ritter moved to certify the Jacksonville/North Pulaski School District results. Commissioner Boyle seconded the motion. Motion passed by voice vote.

Commissioner Boyle moved to certify the North Little Rock School District results. Commissioner Harris-Ritter seconded the motion. Motion passed by voice vote.

The Chief Judge letters will be mailed out for the November 14, 2017 election on Friday, September 29, 2017. Training for the Chief Judges will take place on October 31, 2017 at 10:00 am and November 2, 2017 at 2:00 pm.
