The meeting was called to order at 4:00 p.m. by Chair Pat Hays. A quorum was determined.

Approval of Meeting Minutes

Commissioner Boyle moved to accept the minutes as written; seconded by Commissioner Davis. Motion passed by voice vote.

Business

Swearing in of Commissioner Jason R. Davis County Clerk Larry Crane administered the oath of office to Commissioner Davis.

Certification of Logic and Accuracy Testing for Primary/Nonpartisan Election Testing was held on April 11-13, 2018, additional machines were tested on April 17, 2018. There were 110 iVotronics and 110 M-100's tested for the Primary/Nonpartisan Election Day, in addition to 70 iVotronics and ten M-100's for early voting. There are ten iVotronics and five M-100's available for backup. Commissioner Boyle moved for the Certification of the Logic and Accuracy Testing; seconded by Commissioner Davis. Motion passed by voice vote. Certification of Election Officials for the Preferential Primary/Nonpartisan Election Commissioner Boyle moved for the Certification of Election Officials for the Primary/Nonpartisan Election; seconded by Commissioner Davis. Motion passed by voice vote.

Revised Certification of Polling Locations

Polling locations were revised to reflect that Precinct 102 is located at Moody Chapel AME instead of Meadowcliff Elementary School as previously reported. Commissioner Boyle moved for the acceptance of the Revised Certification of Polling Locations; seconded by Commissioner Davis. Motion passed by voice vote.

Other Business

Act 633-The Voter ID Law

Election officials will be trained regarding the changes that are currently taking place with Act 633, as well as the previous requirements. Election officials that were trained prior to the placement of the injunction will be notified via email regarding the changes, as well as distributed to the polling locations by the area managers on election day.
