Precinct 33, Jacksonville Community Center, will be temporarily moved to Jacksonville Senior Center due to the minimal number of voters for the precinct. Precinct 54, Calvary Baptist Church and Precinct 55, All Souls Church, will be temporarily moved to Glenview Community Center due to the minimal number of voters for the precinct. Commissioner Davis moved for the acceptance of the polling location changes; seconded by Commissioner Boyle. Motion passed by voice vote.
