*Approval of Meeting Minutes*

Commissioner McKinnon moved to accept the minutes as written; seconded by Commissioner Price. Motion passed by voice vote.

**Business**

*Polling Location Change Orders*

Commissioner Price moved to accept the polling location changes for Precinct 60 currently at Highland Valley United Methodist Church to be moved to St. Margaret's Episcopal Church; Precinct 80 which is currently at Henderson United Methodist Church to be moved to Oley E. Rooker Library; Precinct 114 currently at Arkansas Arts Museum to be moved to Historic Arkansas Museum; Precinct 106/107 which is

currently at Little Rock Fire Station #10 to be moved to Calvary Baptist Church in the Heights; seconded by Commissioner McKinnon. Motion passed by voice vote.

*Designation of Polling Locations for the March 3, 2020 Preferential/Nonpartisan Primary Election*

Commissioner McKinnon moved to approve the polling locations for the March 3, 2020 Preferential/Nonpartisan Primary Election; seconded by Commissioner Price. Motion passed by voice vote. Commissioner Price reiterated that public service announcements via print, radio, television, street signage and door signage reflecting the changes regarding the polling locations. Chair Gomez requested that when there are documents that contain multiple pages for the page numbers to appear on the bottom of the pages.

*Certification of Ballot Styles for the March 3, 2020 Preferential/Nonpartisan Primary Election*

Circuit County Clerk Terri Hollingsworth asked for clarification regarding the reviewing of ballot styles. Director Poe explained the process that the staff takes regarding reviewing the ballot styles. There are 537 ballot styles for the March 3, 2020 Preferential Primary Election. The millage proposals for Jacksonville North Pulaski School District and East End School District were read for the record. Commissioner Price moved to certify the ballot styles for the March 3, 2020 Preferential/Nonpartisan Primary Election; seconded by Commissioner McKinnon. Motion passed by voice vote. Commissioner Price thanked the staff for all their hard work in preparing the ballots for the election.

*Approval of Notice of Election for the March 3, 2020 Preferential/Nonpartisan Primary Election*

Commissioner McKinnon moved to approve the notice of election for the March 3, 2020 Preferential/Nonpartisan Primary Election with a stylistic change to follow for the Annual School Election; seconded by Commissioner Price. Motion passed by voice vote.
