Review and Canvass Absentee Ballots for the November 2, 2021 Annual School Election

There were 118 absentee ballots processed by the absentee election officials. Sixteen of these were deemed irregular. After staff review, ten of the irregular absentee ballots were determined to not be counted. The ten ballots the staff determined not to be counted were as follows: six were made provisional for no identification; one was missing the voter statement; three were missing information on the voter statement (date of birth or signature).

Six of the irregular ballots were presented to the commissioners for review. Two of the ballots were for address issues; one was a date of birth issue and three were signature issues. The commissioners determined that four of the six ballots should be counted.
