Commissioner Inman felt that one should be counted. Of the 16 to not be counted, 10 were made provisional for missing I.D. The voters will be sent a letter, an email or receive a phone call advising that they have until Monday, September 20, 2021 at noon to provide their I.D. to the county clerk's office.
